**Intermediary Bank Charges**

For funds transfer through SWIFT, charges are levied by the intermediary banks. These charges can either be borne by the remitter ("you"), the beneficiary or it may be shared. You can select who will pay the charges by opting for OUR, SHA or BEN.

**OUR:** If you want to pay all the intermediary bank charges so the beneficiary receives the entire amount without any deductions, you must select OUR. All correspondent / intermediary bank transaction charges will be borne by you.

**BEN:** If you want all correspondent / intermediary bank transaction charges to be borne by the beneficiary, you must select BEN. Your beneficiary will receive the funds after deduction of the charges.

**SHA:** If you want the intermediary bank charges to be shared between you and the beneficiary, you must select SHA. The transaction charges levied by SBI UK correspondent / intermediary bank will be borne by you and charges levied by the beneficiary bank's intermediary/correspondent bank will be borne by your beneficiary. **For Transactions within the European Economic Area [EEA], SBI UK will by default use SHA irrespective of the currency. OUR and BEN are not eligible due to change in regulations.**

Depending upon the option (OUR, BEN or SHA) chosen by you charges will apply. Please note that these charges would be additional to the normal swift or remittance charges.

In case you have not selected any of the above options, SBI UK will transfer the funds with option **SHA** and charge you accordingly.
